Dear Ambassador Jawad,

Our country has been deceived and lied to by President Karzai who is allowing horrible HUMAN RIGHTS ABUSES against both Afghan and American citizens. Two weeks ago, Americans learned that our country is giving your Taliban terrorist controlled government more than FIVE BILLION dollars in aid, and now we find out that our tax dollars are being used illegally and against American laws. Five Billion dollars of OUR MONEY used by Karzai to continue to torture and imprison innocent Americans, appoint and allow former Taliban leaders into the new government; like the infamous Taliban General Rocketeri who murdered American soldiers during the liberation of Afghanistan, and murdered so many innocent Afghans. Now, today, Karzai appoints Parliament members who include Taleb Arsala Rahmani, who was the Taliban's deputy minister for religious affairs and punishment— a man who tortured and murdered scores of women under his oppressive religious regime.

Americans THINK the Taliban are gone, and that your government is NOT controlled by the Taliban anymore, but it is clear that the Taliban are CONTROLLING your government. Your President appoints **Taliban Terrorist judges to run your courts.** Taliban Judge Abdul Bassett Baktyari could not even get a visa to America because he is a terrorist wanted for questioning, yet your president allowed him to preside over the trial of three Americans! Now Americans learn that you are engaged in human rights abuses from the starvation of the Afghan people to the torture of Afghan and American prisoners in secret torture chambers like the NDS' Saderat Facility located in Kabul and run by a murderer named Armullah Saleh who uses American taxpayer money to murder, electrocute, and beat people (including Americans).

My friend Captain Brent Bennett is a prisoner of war at Pulacharke Prison. He and the other Americans were found completely innocent by an Afghan Court of Appeals and I have personally heard the secret tape-recordings in which the judges say they are innocent.

These human rights abuses must STOP NOW or Americans will MARCH and demonstrate AGAINST your Embassy. You must immediately return electricity, running water, and food to the Pulacharke Prisoners. KARZAI is committing the following HUMAN RIGHTS ABUSES:

1. more than 3,000 prisoners at Pulacharke have been without power for 47 days,
2. without any form of electricity for 47 days;
3. without running water for more than one year;
4. without suitable drinking water for more than one year;
5. without any food except old rice and bread for more than 60 days;
6. the Red Cross is stealing and selling American donated blankets and clothes at the local shops instead of giving them to dying and sick prisoners;
7. honest and kind Ministry of Justice Officials are being stopped from caring for prisoners by Karzai and US Officials in violation of international law.

American officials are also involved in these illegal activities. US Consul Adrienne Harchick has refused to deliver mail and relief parcels to American prisoners in violation of international laws. She has also refused to deliver and send American holiday parcels, claiming Thanksgiving and Christmas violates the Muslim religion.

US Ambassador Zalmay Khalilzad has engaged in continuing anti-Christian activities now carried on by his replacement. They have denied Christmas mail for the second year in a row. Did Hamid Karzai order this? If not then who DID? Have you declared war between Muslims and Christians? What else would explain this?

Were Ministry of Energy officials bribed and coerced to deny electricity to Pulacharke Prison at the orders of PRO-TALIBAN President Hamid Karzai? Was a relative of Karzai paid a bribe by a construction company or American financed radio station in the Pulacharke area to divert electricity so it could be used for the profit of construction companies linked to the Karzai family and US Embassy? If true, this is a disturbing human rights abuse equal to Nazi war crimes. I have been told that Karzai's Palace has REFUSED to provide the anti-Taliban Minister of Justice with money to repair electricity and buy generators for prisoners at Pulacharke Prison and that the Afghan officers at the prisons are bringing blankets and food from their own families to help save prisoners.

While Ministry of Justice Generals and Officials are using their own money and blankets to save prisoners and working every day to help prisoners and keep them safe, high Karzai officials, Ministers (such as Jalali), and NGOs such as the Red Cross are stealing money. The Ministry of Energy is selling electric power to the rich and causing suffering upon poor prisoners and the poor officers at Pulacharke Prison. Ministry of Justice officials should be congratulated. What is shocking is that the officers and officials at the prisons could be so compassionate, yet high officials in the Karzai government could be so inhumane.

As an American citizen I demand you cease your torture and abuse of Americans and Afghans now and by copying this letter to the American officials below I demand the American government and the United Nations lodge immediate diplomatic objections about the lack of water and electricity at Pulacharke Prison and all Afghan Prisons, and formal written objections to Armullah Saleh's torture chamber.

I am calling upon ALL American elected officials, Senators, Congressmen, and Congresswomen to stop all financial aid from being sent from American taxpayers to Afghanistan to used for terrorist activities by a pro-Taliban Karzai government and stolen by Karzai government ministers and officials like Minister Jalali (who fled the country in disgrace last month). I am demanding an investigation and criminal charges against President Karzai, and because Ahmad Ali Jalali is a US Citizen, I am demanding that the US Senate and Congress initiate an investigation into the actions of Jalali, including, but not limited to: torture, suborning of perjury, violations of the Patriot Act, assaults upon US citizens, conspiracy to torture and murder US citizens (NONE of which had any terrorists links or deserved ANY kind of extreme interrogation, rendition, or imprisonment), support of the enemy during war (his well-known Taliban links and support thereof), theft of US Government funds (taxpayers money), bribery of foreign officials with US Government funds, embezzlement of US government funds, making false reports to American federal law enforcement agents, and many other crimes, not the least of which is treason since he continues to hold a US Citizenship, and committed these crimes WHILE A US CITIZEN. I have no part of that website, nor do I even know the person who runs it, but from what I know, just about everything stated is true and accurate.

I especially demand that Hamid Karzai's "Saderat" torture chamber in Kabul, run by Karzai's Intelligence Chief, Armullah Saleh, be shut down. Furthermore, I demand that the UN High Commission for Human Rights investigates War Crimes by Saleh and Karzai, and that the US Senate and Congress conduct hearings and an investigation. And, if grounded in fact and evidence, as I believe it will be, the United States MUST prosecute those responsible for the torture of Americans. This includes US Citizens: Hamid Karzai, Armullah Saleh, Ahmad Ali Jalali, and all other US Citizens involved, including agents of the Federal Bureau of Investigation which were present in Kabul between April 2004 and June 2005.

This is NOT JUST A LETTER FROM A "CONCERNED CITIZEN." I will be a Congressional and Senate witness. I have firsthand direct knowledge as to what really happened between these men and the FBI. Two years ago, I was the typist that transcribed secret tape-recordings of FBI agents and other federal officials. I know what was on those tapes, and therefore I know that certain persons in the US government, including Karzai (I also transcribed his conversations with Jack Idema), Jalali, and others, are not just twisting the truth, but are outright lying and falsifying evidence. For that reason, I request that I NOT BE CONTACTED by any federal law enforcement officer without an attorney present. I am willing to speak alone to any member of the US Senate or Congress.
